2009 Chair's Message

When I reflect on the year just ended, I can't help but think of the infamous quote/curse: "May you live in interesting times." If ever there was an "interesting" year at the Arlington Chamber of Commerce, it was 2009. The national recession had a significant impact on the Chamber and on our member companies. And yet, this was also a period of growth and creative accomplishment for this great organization and for our many volunteer-

driven committees. For example:

- Our **Communications Council** developed a new communication plan for the Chamber that will enhance the Chamber's ability to reach out to our members as it is implemented later this year.
- The **Community Action Committee** continued its successful Volunteer Arlington Days and its Nonprofit Forums, ensuring that our nonprofit members get the most for their membership investment.
- The **Economic Affairs and Government Relations Committee**, in addition to its busy agenda of local issues, took positions on federal issues including the Employee Free Choice Act. The committee broadened its scope and provided important information to our members in the process.
- Despite the economy, the **Education and Workforce Development Committee** gave two scholarships to local students headed to Georgetown and George Mason Universities. At a time when more students need more financial help than ever before to pursue their educational dreams, these grants were significant.
- The **Hotel General Managers Committee** was reinvigorated in 2009, and worked with the Metropolitan Washington Airports Authority to negotiate curb usage at Ronald Reagan National Airport.
- And the **Opportunity Works Campaign Committee** exceeded all expectations—and its own goals—by raising more than \$230,000 to support the Chamber's many programs.

Committees are a place where Chamber members collaborate with each other to get things done. Collaboration with other organizations was also a hallmark of the Chamber last year. We worked with our friends at Leadership Arlington on the State of the County address this spring, and with both Leadership Arlington and the Arlington Community Foundation on a few "Weathering the Storm" events to help local businesses cope with the recession. We also had an ongoing dialog with County Board Chairman Barbara Favola and her staff on the spending of transportation taxes on the business community. I hope we'll keep those lines of communication open going forward. And we've worked with **Arlington Economic Development** on many issues, most recently retail development guidelines.

Recognizing that more and more collaboration is taking place electronically, in 2009 the Chamber stepped into the world of social networking. We created a LinkedIn group to allow our members to network in cyberspace and offered new website forums to those looking for tech advice. Yet, even as the Chamber had one foot in the future with technology, in our 85th year, we also acknowledged and honored our past. As part of a new and expanded ABBIES program, we launched an Arlington Business Hall of Fame, and were pleased to have Arlington business legends Preston Caruthers and Fred Burroughs as our inaugural inductees.

2009 was a busy—and a good—year for the Chamber and I'm grateful to all of you for making it so. It was an honor and privilege to serve as Chamber Chair in this "interesting" year, and I look forward to working with all of you in the months and years ahead.

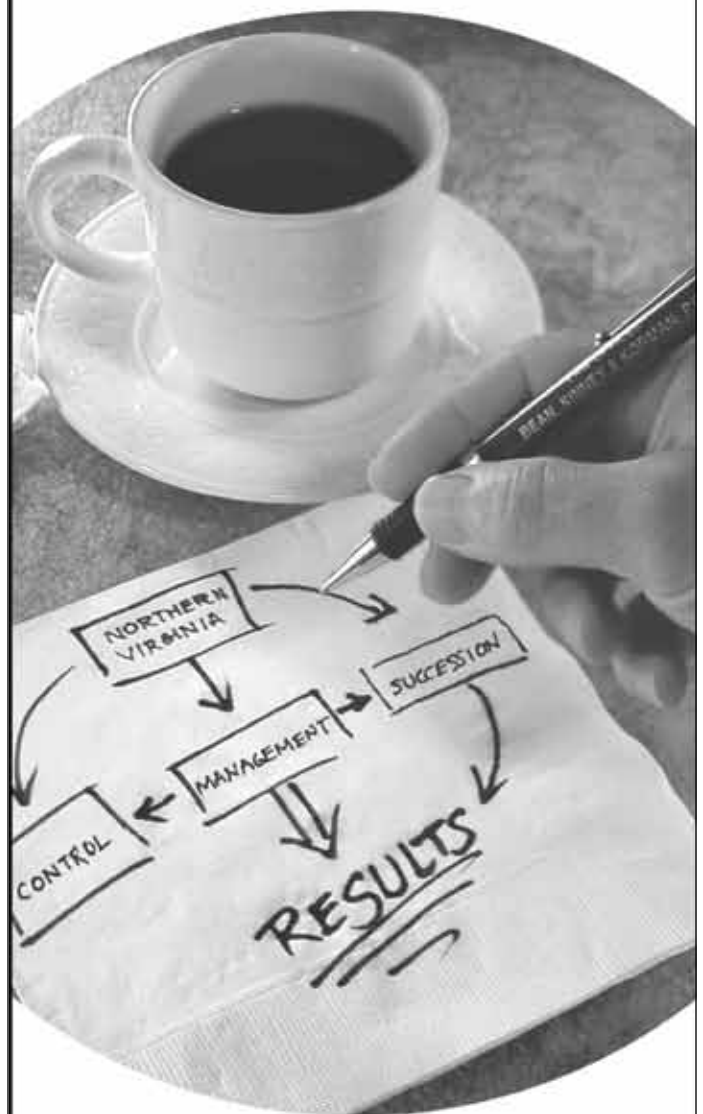

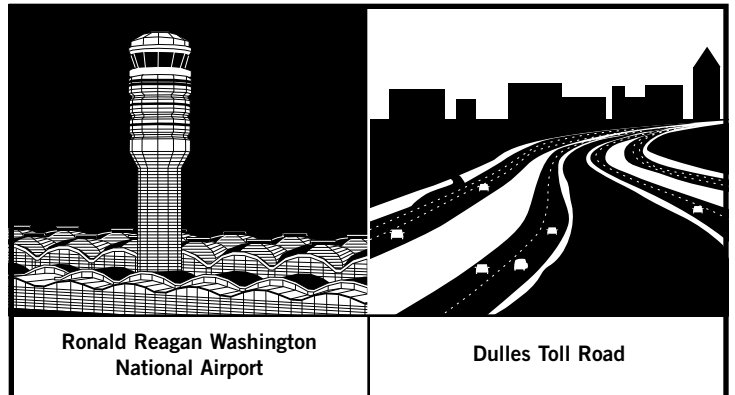

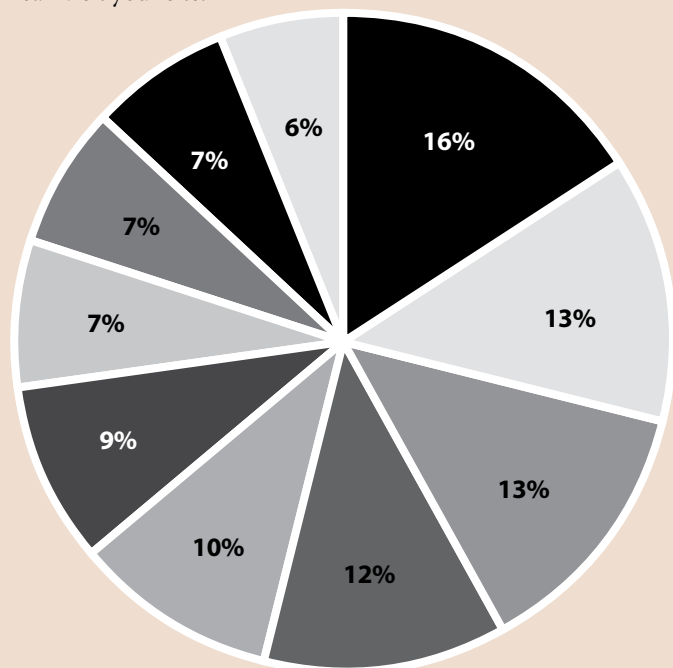

Brammer provided behind the scenes effort as a Board Director and member of the Executive Committee. **Brammer** is also consistently a top-level Opportunity Works participant.

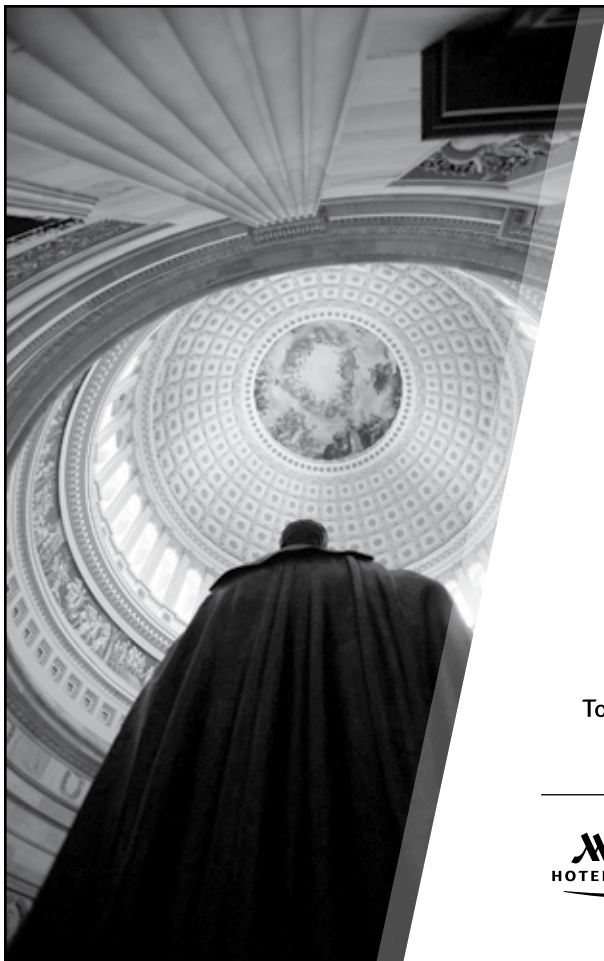
