

### The Value of Economic Development

iven the current economic climate and the challenging future ahead, it will become more important than ever for Arlington to retain its ability to mitigate some of the inevitable consequences of the current economic downturn. Arlington Economic Development's (AED) efforts in 2008 resulted in a direct tax impact of \$10 million annually, and represent successes with tenants who would have made different leasing decisions "but for" AED involvement, development projects that would not have happened "but for" AED leadership, and visitor spending that was directly influenced by ACVS staff. One of Arlington's most effective strategies for weathering the recession will be to maximize commercial occupancy rates.

Maximizing commercial occupancy rates adds value to Arlington in a variety of ways. For instance, the average occupied square foot of office space results in direct non-real estate tax revenues of \$2.078 (includes BPOL, personal property and commercial utility taxes). This is unloaded in that it does not include any induced spending by tenants or any multiplier effects. In 2008, AED staff:

- Were instrumental in attracting new tenants into 565,970 square feet of office space resulting in a net fiscal impact of \$1.2 million;
- Successfully retained or expanded tenants, through new leases, into 737,204 square feet of space with a resulting \$1.5 million in net tax benefit;
- Were responsible for the retention or recruitment of 4,017 jobs; and
- Educated or counseled 1,500 business persons through BizLaunch and successfully found new locations for six displaced small businesses.

These figures are reflective of clearly confirmed successes in that the tenants would have made different leasing decisions "but for" AED involvement. Some of the tenants AED aided in 2008 include Gridpoint, MedStar, Cambridge and Virginia Tech among others.

Value for Arlington is also created through new development. The most definitive examples of projects that would not have happened without AED are the Kettler Capitals Iceplex and the redeveloped Shirlington. Combined, these are producing annual tax revenues in excess of \$4.0 million. In addition to these projects, in 2008 staff:

- Facilitated approval of site plans for Founders Square and 800-900 N. Glebe Road, which were centered on build-to-suit offices for DARPA and Virginia Tech respectively;
- Facilitated the development of five new hotel projects now under construction and containing 1,098 rooms resulting in projected TOT revenues of more than \$3.0 million.

• Accelerated development of 21 commercial projects resulting in \$16.3 million in local tax revenues.

AED's efforts cited above have resulted in a direct tax impact of \$10 million annually, three times our net tax support. Similar results are expected in FY2010. There is no doubt that Arlington faces a challenging road ahead. We do, however, have an opportunity to make this serious situation more manageable by acting strategically, mitigating losses and producing future revenue.

# 84th Annual Meeting: Recapping 2008 and Building Towards 2009

n December 12th, the Arlington Chamber held its 84th Annual Meeting at the Sheraton National Hotel. The event was a celebration of the achievements of 2008 and a look at what is ahead for 2009. The Chamber attracted approximately 250 attendees. The attendees, Arlington business leaders enjoyed a luncheon followed by a visual presentation of "A Retrospective" by Chamber President Rich Doud. The Chamber awarded and welcomed both new and old members. Following the slideshow, the 2008 Chair, Margaret McKeough remarked on the year, thanking the Board, the members, and staff for all of their hard work and gave insight into the exciting 2009 objectives. Margaret McKeough and Rich Doud presented the following awards:

The **2008** Committee of the Year Award, which recognizes the committee that has done an exceptional job of executing the mission of the Chamber membership and Arlington business community and serves the interests of Committee members, was given to the Community Action Committee, which is chaired by Greta Menard, Capitol MarCom.

The Community Action Committee took their flagship event, Volunteer Arlington Day, to a whole new level. This year Volunteer Arlington Day expanded to two days of service, with over 100 volunteers assisting 12 Chamber member nonprofits.

The Community Action Committee expanded beyond their typical activities to create a series of Nonprofit Forums. These quarterly events, free for Chamber members, have provided additional educational and networking opportunities for our members. These events have been extremely successful, with a large number of attendees. Topics so far have included outcome measurement & program evaluation and fundraising strategies.

In addition, the committee hosted the September Breakfast Connection, highlighting the Chamber's non-profit members as part of the networking program.

In recognition for their accomplishments, the committee, as well as the Chamber, was recognized by the community with the prestigious James B. Hunter III Community Hero Award.

The 2008 **Chair's Award**, which recognizes the member organization and its representatives that have made an outstanding contribution of resources to the Chamber and the business community was given to **Bean, Kinney, and Korman, P.C.** who is also one of our Annual Corporate sponsors.

The Chair's Award was established to provide public recognition to a member organization and its Chamber representatives that have made an exceptional contribution to the Chamber through sponsorship, leadership, attendance at events, and other contributions of resources.



### You Either Get Better or Get Worse — **Status Quo is Not an Option**

The Novemebr 2008 Small Business Roundtable discussed the lessons learned this year that can be applied to improve next year's performance. Opportunities seized and pitfalls encountered adds up to experience that will benefit efforts in the arena of possible tough economic times for the next twelve months.

### **Lessons Learned:**

- Communication with prospective clients that the prospect misinterprets or ignores can lead to "firing" a client. This can surface by client requesting an effort not covered by the agreement or asking for "free" work by expanding the scope of the assignment at no additional fee.
- Communications with staff not clearly describing the responsibilities or the expected outcomes of a task resulting in frustration for both the employer and the employee.
- Not applying a sharp pencil to expenses, while not wasteful, the extra cash now would provide a cushion for the anticipated tough business climate ahead.

### **Corrective Action:**

- Give client the option of restricting options or paying for increased hours.
- Rework the proposal to better define the scope of the work.
- Work on communications by requesting feedback from employees or clients to minimize misunderstandings.

The Bottom Line from this roundtable? Times are changing and it's time to change to reflect the current reality. Employ defensive techniques; get closer to your current clients, look for additional ways of bringing value to the table, energize your employees to think about marketing in everything they do.
